

2009 SPECIAL ANNUAL AWARDS PROGRAM GUIDELINES TO FOLLOW

- All nominations submitted must adhere to the following rules. Any application not properly filled out will be rejected.
- All active **members** of the Chapter will have the opportunity to nominate a person from the Chapter, or themselves, for any or all of the awards.
- All nominations must be seconded. The person seconding the nomination must be an active PGA Member of the Oregon Chapter.
- Nomination form must be completed by the individual making the nomination and submitted to the Oregon Chapter office by August 1st. Incomplete nomination forms will not be considered.
- Each nominee will then be notified and sent a formal application. The application must be completed by the nominee and returned to the chapter office by August 20th.
- The Board, Past Presidents, and the Awards Committee will review the candidates' applications on their merits and select a winner in each category.
- The Chapter award winners will then become Oregon's nominee for the PNW Section award in the same category.
- The Chapter award winners will also be recognized at the Annual Awards Banquet.
- PNW Section winners will become the Sections nominee for the National PGA Award.
