Judge: 'Play ball!' 'Pine-tar' contest finally resumed

BASEBALL

An appellate justice overturned an injunction blocking the conclusion of tonight's pine-tar game between the New York Yankees and the Kansas City Royals, two hours before the game was to start.

Justice Joseph Sullivan of the Appellate Division of State Supreme Court in Manhattan stayed a temporary injunction that had been issued earlier in the day by Bronx State Supreme Court Jus-

tice Orest V. Maresca.

Maresca said he had blocked the game "in the interests of justice" and to "protect the rights" of fans who filed lawsuits claiming they should not have to pay to see the completion of the game they attended July 24.

"I guess I can state it best in two words: 'Play Ball!'" Sullivan said in announcing the ruling after a hearing in Manhattan.

The Royals, who boarded a plane and headed east anyway moments after Maresca's injunction, were said to have landed in New York by the time Sullivan overturned the ruling and were en route to Yankee Stadium.

In issuing the temporary injunction, Maresca had cited arguments from attorneys for the Yankees that they feared a "mob scene" at the stadium by fans who would insist on being admitted for free.

The dispute stems from a July 24 game when umpires nullified George Brett's two-run homer for Kansas City at the top of the ninth with two out and the Yankees

leading 4-3.

Umpires ruled Brett had too much pine tar on his bat, declared him out and the Yankees thought they won the game. The decision was later overturned by AL President Lee MacPhail, who reinstated the home run and suspended the game until the final outs could be played.

The Yankees said they needed to charge \$2.50 each for admission to cover security and other costs of the game, which the general office said would run between \$20,000 and \$30,000.

New York Yankees shortstop Andre Robertson, 25, was listed in serious but stable condition in Roosevelt Hospital today with head injuries, a cut arm, abrasions and contusions suffered in an automobile crash several hours after he played in a losing 7-5, 13-inning game against the Chicago White Sox.

A companion, Dawn Nolan, 23, of Dallas was listed in critical condition.

Robertson and Nolan were trapped in the wreckage after the

Yankee infielder's vehicle failed to negotiate an S-turn on a Manhattan highway shortly after 5 a.m. and hit several retaining walls. The car had flipped over, badly damaging the front end.

To those fans who watched the 88 games he played for the Cleveland Indians, veteran second baseman Manny Trillo has a message: Good riddance.

"I heard about Cleveland before. I didn't want to come here," Trillo said after the Indians traded him to the Montreal Expos for minor-league outfielder Don Carter and an undisclosed amount of cash.

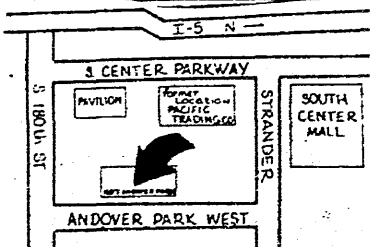
