AUTHORIZED GUESTS: An authorized guest is a person who is affiliated with a club but does not have authority to purchase merchandise for the pro shop. This person is the guest of the PGA Member or Apprentice. Examples might include a club's general manager and spouse, non-PGA pro shop staff, etc.
