Professionals must meet the PNW Section eligibility, employment and education requirements, hold a current PNW Section Player's Card, and properly enter the tournament to retain this exemption. In addition to their education requirements, PGA Associates must complete PGA PGM Level I before being eligible to utilize these exemptions

- 16 Any professional who has participated in nine or more of the last immediate ten Senior Oregon Open events.
- 17 Any professional who has participated in nine or more of the last immediate ten Senior Washington Open event.
