2020 Exempt Amateurs

The following provisions from the Pacific Northwest Section Tournament Regulations cover amateur exemptions to the Washington Open Invitational, Rosauers Open Invitational and the Northwest Open Invitational.

9. EXEMPTIONS AND EXEMPTION CATEGORIES

e) Amateur Exemptions:

- (1) Current State Amateur Champions in the following states provided those champions reside in the Pacific Northwest Section of Idaho, Oregon, Montana, Washington and Alaska.
- (2) Current PNGA Champion provided he resides in the Pacific Northwest Section.
- (3) Top 5, and those tied for 5th place, who place among the top 25 finishers overall in the previous year's edition of event being played.
- (4) All past champions of event being played.
- (5) Members of the last Hudson Cup Team.
- (6) Host club members (up to 3).
