The following provisions from the Pacific Northwest Section Tournament Regulations cover amateur exemptions to the Washington Open Invitational, Rosauers Open Invitational and the Northwest Open Invitational.

9. EXEMPTIONS AND EXEMPTION CATEGORIES

e) Amateur Exemptions:

- Current Men and Women State Amateur Champions in the following states provided those champions reside in the Pacific Northwest Section of Idaho, Oregon, Montana, Washington and Alaska.
- (2) Current Men and Women PNGA Champion provided he/she resides in the Pacific Northwest Section.
- (3) Top 5, and those tied for 5th place, who place among the top 25 finishers overall in the previous year's edition of event being played.
- All past champions of event being played. (4)
- (5) Members of the last Hudson Cup Team.
- (6) Host club members (up to 3).

In the following categories the champions must be residents of the Pacific Northwest Section:

- (7) Men and Women PAC 12 Champion.
- (12) USGA Public Links Champion.
- (8) Men and Women NCAA Champion.
- (13) Men and Women USGA Senior Amateur Champion.
- (9) Men and Women NAIA (National) Champion.
- (14) Pacific Coast Amateur Champion
- (15) Low Amateur, US Open
- (10) Men and Women USGA Amateur Champion.
- (11) Men and Women USGA Mid-Amateur Champion.
