Details of Program:	<p>Used the grant as prizes for multiple competitions during PGA Jr. League practice (picture and receipts below).</p> <p>Our PGA Jr. League program is open to members and guests, allowing us to host a large in-house league (maximum 72 players in the summer and 48 in the fall) for 13u.</p> <p>Retention is important to us, we have consistently been near our maximum number of players each year, but try to bring the same players back to allow for growth as golfers. This also helps the talent level of our All-Star team.</p> <p>We make sure to schedule consistent practice and match dates for both the 13u and 17u program, to allow parents adequate planning for the season.</p>
Results of Program:	<p>Meridian Valley achieved a Gamechanger Award from PGA Jr. League as the 15th largest program in the country.</p> <p>We had 3 teams qualify for the Section Championship at Eagle Crest, the most our program has ever had.</p>
