CONDITIONS OF ENTRY

The conditions of entry are set forth by the PGA of America and are detailed on the entry information supplied to prospective entrants by the PGA of America. Information supplied by the PNW Section is informative in nature and is not binding on the conduct of the championship.

NON-METAL SPIKE RELEASE: If it is the requirement of the Host Club that all individuals using the Host Club golf course wear spikeless/non-metal golf shoes. This requirement is a policy of the Host Club and is not a policy of the Pacific Northwest Section of the PGA of America ("Section"). The use of spikeless/non-metal golf shoes may result in the participant slipping on wet or damp surfaces (inclusive of but not necessarily limited to turf area, wooden areas such as bridges and pathways, etc.) and reduced traction on non-level areas of the golf course. As evidenced by the participant's signature on the front of this entry, the participant acknowledges that potential dangers relative to the use of spikeless/non-metal golf shoes have been disclosed to participant and participant agrees to assume the risk of sustaining injury arising from or attributable to the use of spikeless/non-metal golf shoes at the Host Club's premises. The participant here releases the Section and Section's officers, directors, members, employees, successors and assigns (the "Indemnified Parties") from any and all claims for loss damage, inclusive of but not limited to personal injury, whether or not caused by participant's use of spikeless/non-metal golf shoes at the Host Club's premises in connection with the tournament. The consideration for this release is the permission granted by Section to the participant to participate in the golf tournament. This release binds not only the participant, but also the participant's spouse, heirs, legal representatives and assigns.

By this application, an applicant consents to references to him and pictures of him and his play in any publicity, radio and television broadcasting and other exhibition or publication, including their use in any commercial manner.

STARTING TIMES: Groupings will be available at the Section office on Friday, July 31 or at the Section website at www.pnwpga.com. Competitors are responsible for knowing their starting time and tee. Players will not be called to their starting tee.

ELIGIBILITY:

The Pacific Northwest Section PGA Assistant Professional Championship is open only to A-8's and all Apprentices of the PNW Section that are eligibly employed and in good standing. For complete eligibility information, see the entry form supplied by the PGA of America.

A-6's employed as assistants may be eligible to play but **MAY NOT** represent the Section at the National Championship.

The PGA of America has adopted the condition of competition for Grooves and/or Punch Marks at the Section level of the Pacific Northwest PGA Assistant Championship. Starting this year, **ALL PLAYERS MUST comply with this condition of competition.**

DRESS CODE: Professionals may not wear jeans, shorts or skirts in the championship.
